Strategy

The portfolio managers look to invest in quality companies at attractive prices. They identify them through various quantitative screens and in-house research and then 'conduct their own fundamental analysis. The quality characteristics they look for include sustainable high returns on capital that will enable the company to grow faster than competitors and generate high cash flows. ESG analysis is part of the investment decision making process alongside consideration of the quality and valuation of a business. When assessing investment ideas, the team establishes a "fair value" range for each stock on a cross-cycle basis and invest if the opportunity offers an attractive risk/ reward balance. They believe companies with these attributes tend to outperform the market over the long term.

Objectives & Investment Policy

Objective: The fund aims to achieve capital growth over time. **Investment Policy:** The fund invests at least 70% (and normally 75%) of its assets, in equities of companies listed on European stock exchanges. The fund may also invest in money market instruments on an ancillary basis. The fund invests at least 50% of its assets in securities of companies with favourable environmental, social and governance (ESG) characteristics.

Investment Process: In actively managing the fund, the Investment Manager considers growth and valuation metrics, company financials, return on capital, cash flows and other measures, as well as company management, industry, economic conditions, and other factors. The Investment Manager also considers ESG characteristics when assessing intentions to the control of investment risks and opportunities. In determining favourable ESG characteristics, the Investment Manager takes into account ESG ratings provided by Fidelity or external agencies. Through the investment management process, the Investment Manager aims to ensure that investee companies follow good governance practices.





Cumulative performance in EUR (rebased to 100)


