/ Portfolio description

The primary objective of the portfolio is to achieve long term capital appreciation by investing in a concentrated portfolio of global equities. The portfolio manager acquires global equities at levels below the assessment of the companies' fair values. The portfolio manager also takes cognisance of global economic, sector and investment trends to tilt the portfolio towards attractive regions, sectors, and companies. The Integrity Global Equity Fund is required to invest a minimum of 80% of the portfolio in equities and is therefore suitable for investors with an investment horizon of five years or longer.

Integrity diligently follows a value investment philosophy and process. This is the same investment philosophy and process applied in managing the Integrity Global Equity Strategy, with track record since 11 September 2012.

The portfolio has adhered to its policy objective since its inception.


/ Sector allocation



/ Relative performance

Over the quarter, the Fund achieved a return of 2.79% compared to the benchmark of 8.20%. The Fund was negatively impacted by not holding any of the FANGMAN (Facebook, Amazon, Netflix, Google, Microsoft, Apple & NVIDIA) counters. This alone generated a negative contribution to return of 2.66%. Conversely, the Fund benefitted from its top performing shares during the quarter, namely; Berkshire Hathaway, Safran, and Mercedes-Benz. The market was materially impacted by the increased positive sentiment globally with a significant preference towards growth shares over value shares during the period. Impala Platinum was the largest detractor from alpha as a result of the share price decreasing alongside the average Platinum Group Metals (PGMs) basket price over the quarter. The Fund was also negatively impacted by the performance of Paramount Global and Intel Corp. The MSCI ACWI Value Index had a total return of 6.85% over the guarter compared to the MSCI ACWI Growth Index of 9.50%. As global economic activity remains strong, we expect that bond yields will continue upwards. The mentioned backdrop should be supportive of value over growth.

/ Fund composition

The Investment Manager made several portfolio changes over the guarter which resulted in a significant decrease in the Fund's total equity exposure, specifically to counters in the financial and consumer discretionary sectors. The Investment Manager decreased exposure to Berkshire Hathaway and Mercedes-Benz which performed well and their discounts to their estimated fair values narrowed. Additionally, exposure was initiated to Carrefour which the Investment Manager believes offers significant upside potential at current market levels. The Investment Manager exited exposure to counters which went above their estimated fair values, namely; Citigroup, KB Financial, Honda Motor, Safran and Daimler Truck Holding. Lastly, the Investment Manager increased exposure to Vodafone Group, Analo American, British American Tobacco, CK Hutchison, Glencore and Impala Platinum over the quarter.
