Fund objective

Abax SA Balanced Prescient Fund is a domestic fund with a mandate to invest across a wide range of South African asset classes.

The Fund is suitable for retirement savings and complies with Regulation 28.

The Fund's primary objective is to outperform the peer group (as measured by the ASISA South African MA Flexible Category Average) on a net fee basis over the medium term.

The Fund has a moderate to high risk profile, and is suitable for investors seeking long-term capital growth and moderate levels of income, who can tolerate the associated high levels of capital volatility.

The Fund is not permitted to invest in offshore investment markets. The Fund will have an effective equity exposure of up to 75% and a maximum effective property exposure of up to 25% of the market value of the portfolio.

About the Fund

The Fund will be a diversified portfolio of South African listed and unlisted, equity, bonds, money market and property instruments that will harness the unique and proven skill set of the Abax investment team.

The Fund is managed by Matthew de Wet and Omri Thomas.

Definitions

Annualised performance - Annualised performance show longer term performance rescaled to a 1 -year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest return - The highest and lowest returns for any 1 year over the period since inception have been shown. NAV - The net asset value represents the assets of a Fund less its liabilities.

Sharpe Ratio - The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation - The deviation of the return stream relative to its own average.

Max Drawdown - The maximum peak to trough loss suffered by the Fund since inception.

Benchmark - *SA Balanced Benchmark - Composite benchmark comprising of 60% Capped SWIX (JSE Capped Shareholder Weighted Index),

60% Capped SWIX (JSE Capped Shareholder Weighted Index) and 20% Stefi Call Deposit rate.

Forward pricing is used. The Fund's Total Expense Ratio (TER) reflects the percentage of the average Net Asset Value (NAV) of the portfolio that was incurred as charges, levies and fees related to the management of the portfolio. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER cannot be regarded as an indication of future TER's. During the phase in period TER's do not include information gathered over a full year. Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. Fund Performance has been calculated using net NAV to NAV numbers with income reinvested.
