#### MINIMUM DISCLOSURE DOCUMENT

#### INVESTMENT AND RETURN OBJECTIVE

The Fund aims to return STeFi Call + 3% per annum through a full interest rate cycle by offering investors an enhanced income yield without undue risk on capital by maintaining constrained credit risk exposure.

#### INVESTMENT PROCESS

The Fund invests in a diversified portfolio consisting primarily of South African vanilla debt, mezzanine and structured instruments across the term structure and credit rating bands. Portfolio risk is managed at both single issuer and portfolio level. The former is done through an inhouse dynamic probability of default (PD) based rating model and the latter is through measuring the Expected Loss (EL), Loss Given Default (LGD) and credit VaR (Value at Risk). The Fund's modified duration will typically be below two years. Credit asset selection is underpinned by minimising default risk and credit spread duration.


#### WHO SHOULD INVEST

**RISK INDICATOR**

#### **RISK INDICATOR DEFINITION**

This portfolio typically has longer dated and complex credit exposures, resulting in some capital volatility and liquidity constraints to investors over the shorter term. It is managed in such a manner that the probability of capital losses over one-year periods is unlikely, and in a manner that would cater for client redemptions appropriately.





#### FUND COMMENTARY

April saw some calm return to local Fixed Income markets, with the ALBI posting a return of 1.37% for the month. On the global macro front, recent communication from Federal Open Market Committee (FOMC) participants acknowledged substantial advancements toward the committee's two percent inflation target over the past year, notwithstanding firmer-than-expected inflation readings in recent months. Overall, participants reiterated their vigilance toward inflationary risks, while anticipating some irregularities in monthly inflation indicators during the process of inflation returning to target levels.

Debt Capital Market (DCM) activity slowed in April with R11.7 billion of term issuance (April 2023: R4.6 billion), relative to the R18.5 billion seen in March. In the banking sector, Standard Bank Limited issued R3 billion in senior paper across various tenors via auction, and Nedbank Group placed R1.7 billion of Tier 2 paper. Further noteworthy issuance was seen in the property sector with R3.9 billion of issuance. This includes Stor-Age's inaugural DCM auction, raising R500 million, and Growthpoint Properties issuing R1.1 billion. Furthermore, we saw Sappi returning to the DCM, issuing R1.5 billion across three notes at a well-supported auction. Total term issuance for the year is thus reported at R42.3 billion, compared to R57.4 billion during the first 4 months of 2023.

Regarding our view on credit markets, our theme is determined by a combination of the output of our Credit Cycle Indicator (CCI), our consideration of individual counterparty default probabilities and finally the yields offered on these opportunities. Our CCI suggests continued heightened risk levels inherent in the South African Credit market, and the Fund positioning talks to holding assets with what we believe to have defensive characteristics, while opportunistically taking on additional risk as and when this is deemed appropriate.

The Fund reported a net return of 96bp for the month, while the benchmark performance measured 89bp. The Fund's gross yield is at 12.22%, modified duration is at 1.55, and its weighted term to maturity is at 4.6 years.

#### GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.

Forward Yield: The Forward Yield is the expected combined income of the instruments in the portfolio over the next year expressed as a percentage of the current value of those instruments.

#### **Fund Specific Risks**

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
