INVESTMENT AND RETURN OBJECTIVE

The Fund aims to deliver returns close to the FTSE/JSE Africa Shareholder Weighted Total Return Index at low cost. Although the Fund is structured similarly to the SWIX, it can out / underperform the SWIX by small amounts over time.

INVESTMENT PROCESS

The Fund follows an investment policy which firstly endeavours to follow the composition of the SWIX closely and secondly seeks enhancement opportunities to secure for investors an optimum overall return. In addition to investing in physical assets, the Fund can use derivatives to create exposure to the SWIX or subsets thereof in a low cost and efficient manner

WHO SHOULD INVEST

Investors who are seeking long term capital growth through exposure to the South Africa equity market by investing in a fund with a low tracking error relative to the SWIX and who are cost conscious.


RISK INDICATOR DEFINITION



FUND COMMENTARY

At the onset of the second quarter developed and emerging market diverged like two ships on different courses. After five consecutive months of gains, developed markets experienced a downturn, whereas markets with greater weightings in the mining and energy sectors fared better. While there was no FOMC meeting in April, members signalled the reduced likelihood of the initiation of monetary policy easing, at least until late 2024. The MSCI World Index declined by 3.69% in April, tempering overall performance to a modest 4.84% gain year-to-date (YTD). In the US, the S&P 500 Index dropped by 4.08%, and retraced the YTD figure to a positive 6.04%. Investors responded to higher-than-expected inflationary pressures, coupled with the reappraisal of looming interest rate cuts. Interest rate sensitive sectors suffered as a result. Both technology and real estate relinquished gains accrued in March. European shares mirrored the US trend, with the Eurostoxx Index giving back 3.50%. Economic data however was supportive of the ECB tilting towards cutting rates in June. Moving further east, the Nikkei 225 Index in Japan lost 8.57% for the month as profit-taking in large-caps and semiconductor shares ensued. Conversely, the lower-valued Chinese market had a stronger month, recording a gain of 2.87%. The undercurrent – stronger GDP and PMIs, driven by improved export growth. The MSCI Emerging Markets Index, buoyed by higher commodity prices, posted a modest 0.45% gain, up 2.83% YTD, albeit still underperforming developed counterparts.

Locally, resources shares knocked the ball firmly onto the green with an impressive 7.02%, taking the index into positive territory YTD, up 6.50%. Financials and Industrials eked out a modest return of 0.54% and 1.04%, respectively as the Rand strengthened 0.84% against the US Dollar.

The FTSE/JSE Shareholder Index closed the month up 2.95%. The Fund was ahead of the benchmark, up 3.29% (gross of fees) for the month.

Contributors to Performance:

The positions that contributed most to the absolute performance of the fund for the month were Anglo American (+32.64%), Naspers (+7.44%), and Capitec Bank (+11.07%).

Detractors from Performance:

The largest detractors from the month's absolute performance were Richemont (-8.30%), Bid Corporation(-6.55%), and Sasol (-8.97%).

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Dividend Yield: The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.

PE Ratio: The weighted average price earnings ratio of all the underlying equity in the Fund. The price earnings ratio of each company is the price divided by the earnings per share.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
